- 1. I confirm that I am in a good state of physical and mental health to train Taekwondo and partake in events organized by the ITL and that I am not under influence of any medication, prescribed or otherwise.
- 2. I acknowledge that the activities associated with the ITL, along with the sport of Taekwondo, present a risk of injury. I understand that even while under the guidance of the ITL coaches, I am still at risk of injury.
- 3. I assume full responsibility for my actions and their consequences and the actions of any and all guests I bring to the ITL premises and/or events. I assume full responsibility for any and all inappropriate actions I may take. I also understand and abide by the code of conduct stipulated in the ITL statute.
- 4. I agree to assume full responsibility of any and all risks, injuries and damages, known and unknown, of whatsoever kind and nature, which I might incur as a result of participating in training and events organized by the ITL at any location.
- 5. In consideration of being permitted to participate in training and events organized by the ITL, I knowingly, voluntarily and expressly waive any and all claims that I, or my estate, my heirs, or any person claiming under me completely and without reservation that I may have against the ITL, its committee, its staff, coaches and representatives from any and all kinds of injuries or damages that I may sustain as a result of participating in all activities associated with the ITL.
- 6. I consent to all medical treatment, which may be deemed advisable in the event of injury, accident and/or illnesses during the activities at any ITL events, at any premises.
- 7. I shall assume all responsibility for injuries, losses or damage I may sustain, whilst representing the organization in local and foreign competition.
- 8. I grant the ITL permission, my consent and authorization to publicize any photos, videos, write ups or media of any sort, of myself, my child, my guests on any ITL related or government related source.
- 9. Any offences or abnormal behavior that has been noticed by, or brought to the attention, of any ITL official or the operator, administrator/owner, about any member/members or their representatives/ guardians/parents, may result in instant dismissal of the member/ athlete/ representative/ guardians, or parents without any need for further explanation.
- 10. The ITL reserve the right to refuse renewal of membership of any member, without having to give any reason or explanation for doing so. In the case of refusal of renewal of membership, the member will from that moment cease to be a member of the club.
- 11. The ITL reserve the right to suspend or expel a member or their representative/ guardian/parent, at any time, without having to give any reason or explanation for doing so.
- 12. I as the student/athlete, guardian/parent of an athlete (guardian/parent for all athletes or guests under the age of 18) have read and fully agree with the above release and waiver of liability and fully understand its contents.

The ITL Committee declares with this form, that any member/athlete/guardian/parent/s signed on this form, are free to not renew their membership with ITL and stop attending the ITL, temporarily or completely, at any point that they decide to do so, without having to give any reason or explanation for doing so.
